

**DBE Goal for Clarksville Transit System
Federal Transit Administration ID # 1121**

The Clarksville Transit System (CTS) ID# 1121 has established its goal for the Disadvantaged Business Enterprises (DBE) for fiscal years 2018, 2019 and 2020. The goal was prepared in accordance with the 49 CFR, Part 26 dated February 2, 1999. The goal setting methodology used was the CTS consulted with the Clarksville Chamber of Commerce, the Industrial Development Board, the Montgomery County office of the Tennessee Department of Employment Security and the Clerk's office for Montgomery County, Tennessee and made attempts to contact the Hispanic Organization for Progress and Education, to try and determine if they had any information about the number/types/minority businesses in the Clarksville-Montgomery County TN area.

CTS used the 2015 U.S. Census Bureau County Business Pattern (CBP) database information for the City of Clarksville, Montgomery County, the five counties that border Montgomery County: Cheatham, Dickson, Houston, Robertson, and Stewart, and Davidson County was included because of its proximity to Montgomery County and its heavy concentration of industry and service.

Step 1:

The Tennessee Uniform Certification Program (TNUCP) has 112 certified DBE's in its TNUCP listing in our area that are available for our anticipate contract awards. (Attachment 1)

According to the Census Bureau's County Business Patterns (Attachment 2), there are 12,800 businesses in the CTS market with the ability to provide services in the same NAICS codes. (NAICS codes: 238170, 541310, 813920, 336320, 336330, 336340, 336350, 336390, 237310, 238990, 236220, 323110, 561720, 561790, 621999, 237130, 334220, 423620, 811213, 334290, 423610, 561621, 541511, 238290, 423130) Therefore, the base goal for the CTS is:

The base goal was established by identifying the work elements and their associated costs to determine their weighted percentage of the total work. The number of DBEs and non DBEs were identified by element of work to determine their weighted availability. The weighted percentage was multiplied by the weighted availability to arrive at a base goal of .16%. (Attachment 3)

Step 2:

No step 2 adjustment was used. The goal of .16% race-neutral was rounded up to 1% race-neutral.

No other agency/entity goal was used.

The CTS's past annual goals are as follows. The 2015 goal was projected at 1% through race neutral means. In 2015 CTS awarded 0.0%. The 2016 goal was projected at 1% through race neutral means. In 2016 CTS awarded 0.15%. The 2017 goal was projected at 1% through race neutral means. To date, CTS has awarded in 2017 0.0%. There were no race conscious percentages during the past three years. The average three year attainment was 0.005%. The 0.16%, base goal, will be rounded to the actual **three year race neutral goal of 1%**
