RE: Annual Citizen Complaint Survey (2018)

As set forth in Clarksville Police Department General Order C-9, this document serves as the annual summary of citizen complaints made against Clarksville Police Department personnel for the year of 2018. During 2018, eight (8) incidents resulted in citizen complaints being lodged against department personnel. The 8 incidents involved 10 different departmental employees. The incidents were classified in the following categories:

- Racial Bias Allegations 0
- Traffic Violations Allegations 0
- Rudeness 1
- Policy Violation Allegations 4
- Criminal Allegations 1
- Excessive Force Violations 0
- Other 2

The following findings were concluded after the investigation.

- All allegations sustained 1
- All allegations not sustained 2
- All allegations unfounded 5
- Administratively closed 0

A summary of each incident produced by IA PRO software is attached for your review.

I have found no deficiencies in the procedures in receiving, investigating and tracking of Citizen Complaints.
